- maintenance of the China TBT-SPS website
- information exchange and international cooperation activities

## Mechanism on Coordination among Government Departments

## Inter-ministerial Coordination Conference on Technical Measures to Trade

**Consisting of 18 ministries** 

**Developed the document:** 

Temporary guidance for the notification and enquiry work on TBT issues

## The notification procedure

- The regulatory agency determines what and when to notify and fill out the notification forms
- Enquiry Point check the notification forms
- Notification Authority review the forms again
- Permanent Mission in Geneva submit the final version to WTO Secretariat

## Work with regulatory agencies

#### Hold seminars

- to discuss the TBT principles
- to explain the requirements of filling in the notification form
- to exchange experiences on notification

## Under what condition should a notification be made

- relevant international standard does not exist
- technical content is not in accordance with international standard
- may have significant effect on trade of other Members


# When a notification should be made

- At an early appropriate stage, when a draft is available
- Before adoption (being approved by the government department)
- Amendments can still be made and
  comments can be taken into account

## Which committee should a notification be submitted to

Objectives

Protect human or animal or plant life or health from risks arising from pest, diseases, additives, toxins, contaminants, etc.



## Is it an Urgent Notification?

## When safety, health, environmental protection or national security problems arise or threaten to arise, upon adoption of new requirements Members shall:

- Notify the measure immediately to the WTO Secretariat, the products covered, the objective and rationale, and nature of urgent problem
- Provide copies of the measure upon request
- Allow reasonable time for Members to comment in writing without discrimination
- Publish or make available adopted measures
- Discuss comments & take them into account

# With what format should notification be made

The format is set by the TBT Committee detailed instruction is in G/TBT/1/Rev.8 Section III

We made the Chinese and English bilingual version

#### How to fill in the notification form

Particular attention should be given to aspects such as:

- as complete as possible
- no item should be left blank
- Final date for comments

(60 days after distribution by the WTO Secretariat)

- Proposed date of adoption (90 days after distribution by the WTO Secretariat)
- Proposed date of entry into force (6 months after adoption)

### Technical check for the forms

- Give a serial number for new notification
- Examine if each item of the Chinese form is filled out appropriately
- Consult with regulatory agency to make necessary modifications
- Review whether the Chinese form is translated accurately into English
- Confirm by regulatory agency of the final version
- Make a dossier (include the original and final form, the full text of the document and the record of the process)

### After notification circulated

- Upload the notification information on website: http://www.tbt-sps.gov.cn
- Upon request, provide the full text in PDF format
- Consult with regulatory agency to answer request for prolonging comment period

### Deal with comments

- Receive comments from other WTO Members
- Translate into Chinese if possible, then pass to regulatory agency
- Regulatory agency prepare the reply in Chinese and English
- Review the translation version
- Submit the reply to relevant Member
